No. 4-14/2011-Min.I.- In partial modification to the Cabinet Division's earlier Notification of even number, dated 26<sup>th</sup> October 2011, the Prime Minister has been pleased to order the following amendments in the allocation of subjects, in the manner as given below:

I NATIONAL HERITAGE AND INTEGRATION DIVISION

1. "Pakistan National Council of Arts", previously under the Information and Broadcasting Division, shall also be placed under the National Heritage and Integration Division.
2. "Department of Archaeology and Museums", previously under the Capital Administration and Development Division shall be transferred to the National Heritage and Integration Division.
3. "Iqbal Academy Pakistan" shall be transferred from IPC Division alongwith Aiwan-e-Iqbal to the National Heritage and Integration Division.
4. Standards of Higher Education placed at Sr. No. 8 under the National Heritage and Integration Division shall be deleted.

II NATIONAL REGULATIONS AND SERVICES DIVISION

1. "Academy of Educational Planning and Management" allocated to the National Regulation and Services Division shall continue to be under the Professional and Technical Training Division.
2. The following Organizations placed at Sr. No. 13 and 14 under the National Regulation and Services Division shall be deleted:
  - a. Women and Chest Diseases Hospital Rawalpindi
  - b. Federal Government Tuberculosis Centre Rawalpindi

III NATIONAL FOOD SECURITY AND RESEARCH DIVISION

The following entries, presently under the Commerce Division shall be transferred to the National Food Security and Research Division:

1. Animal Quarantine Departments / Stations / Facilities located any where in Pakistan.  
National Veterinary Laboratory, Islamabad.  
Laboratory for Detection of Drugs Residues in Animal Products at Karachi.

2. Veterinary drugs, vaccines and animal feed additives:  
i. import and export; and  
ii. procurement from abroad for Federal requirements and for inter-provincial supplies

3. Livestock, poultry and livestock products:  
i. import and export; and  
ii. laying down national grades.

4. Procurement of foodgrains, including sugar:  
i. from abroad;  
ii. for Federal requirement;  
iii. for inter-Provincial supplies; and  
iv. for export and storage at ports.

5. Grading of agricultural commodities other than foodgrains, for exports.

Amendments in the Rules of Business 1973, wherever necessary, will be issued in due course.
